Pirogov, "Social opinion should unite the people, foster a spirit of patriotism, ensure that the connections between the state and society are not severed, and support political and economic initiatives. It plays a direct role in the decision-making process of political decisions by the subjects of state and society governance"[3;368].

Social opinion consists of the thoughts and attitudes of people regarding political, economic, social, cultural, ecological, and technological issues in society, and serves as the basis for making various decisions in society. Social opinion can be interpreted as the sum of the views, approaches, beliefs, and convictions of citizens living in a particular society, the state of public consciousness, psychological condition, and their attitudes towards facts and events in the fields of economics, politics, self-awareness, and culture within social reality.
